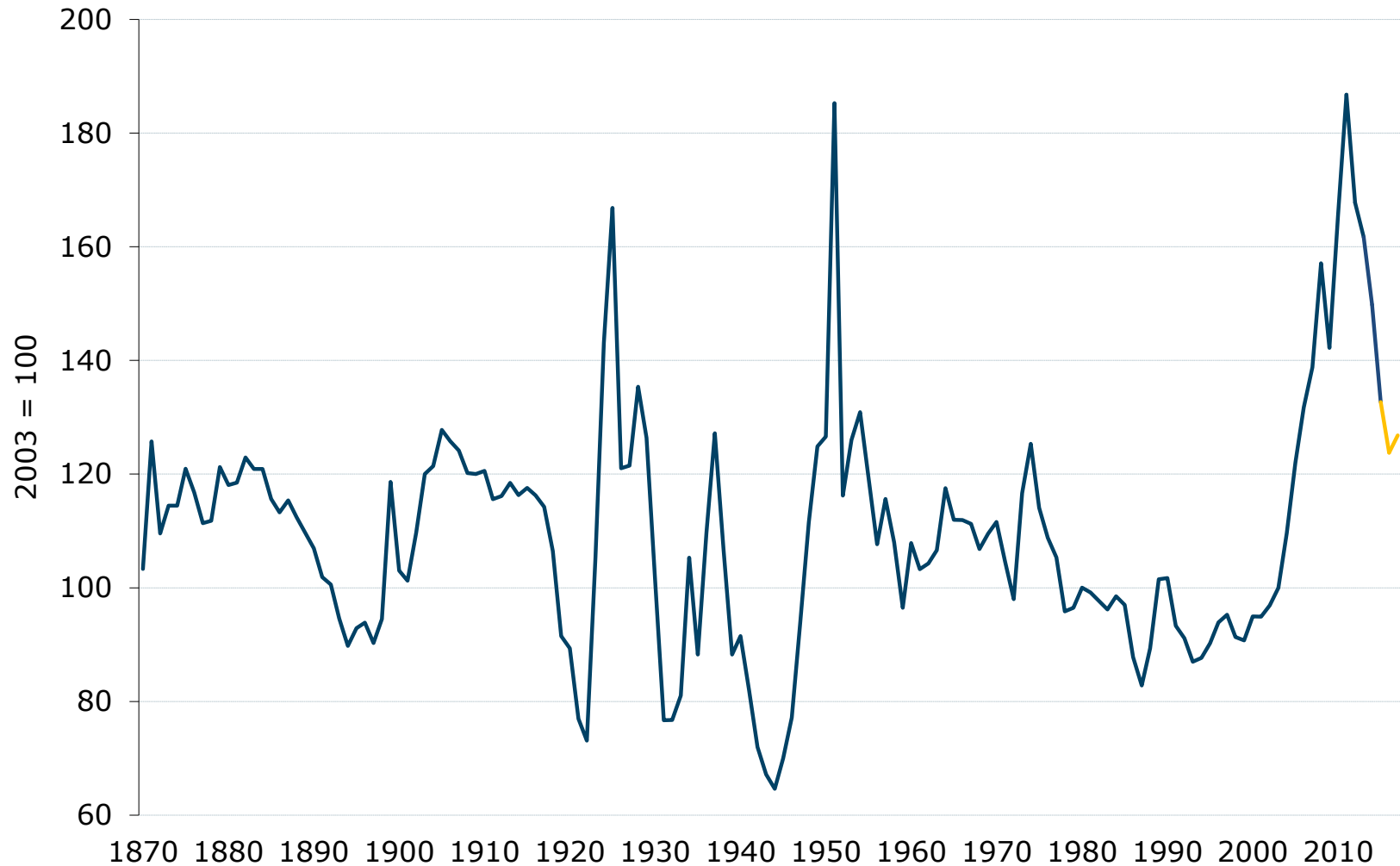

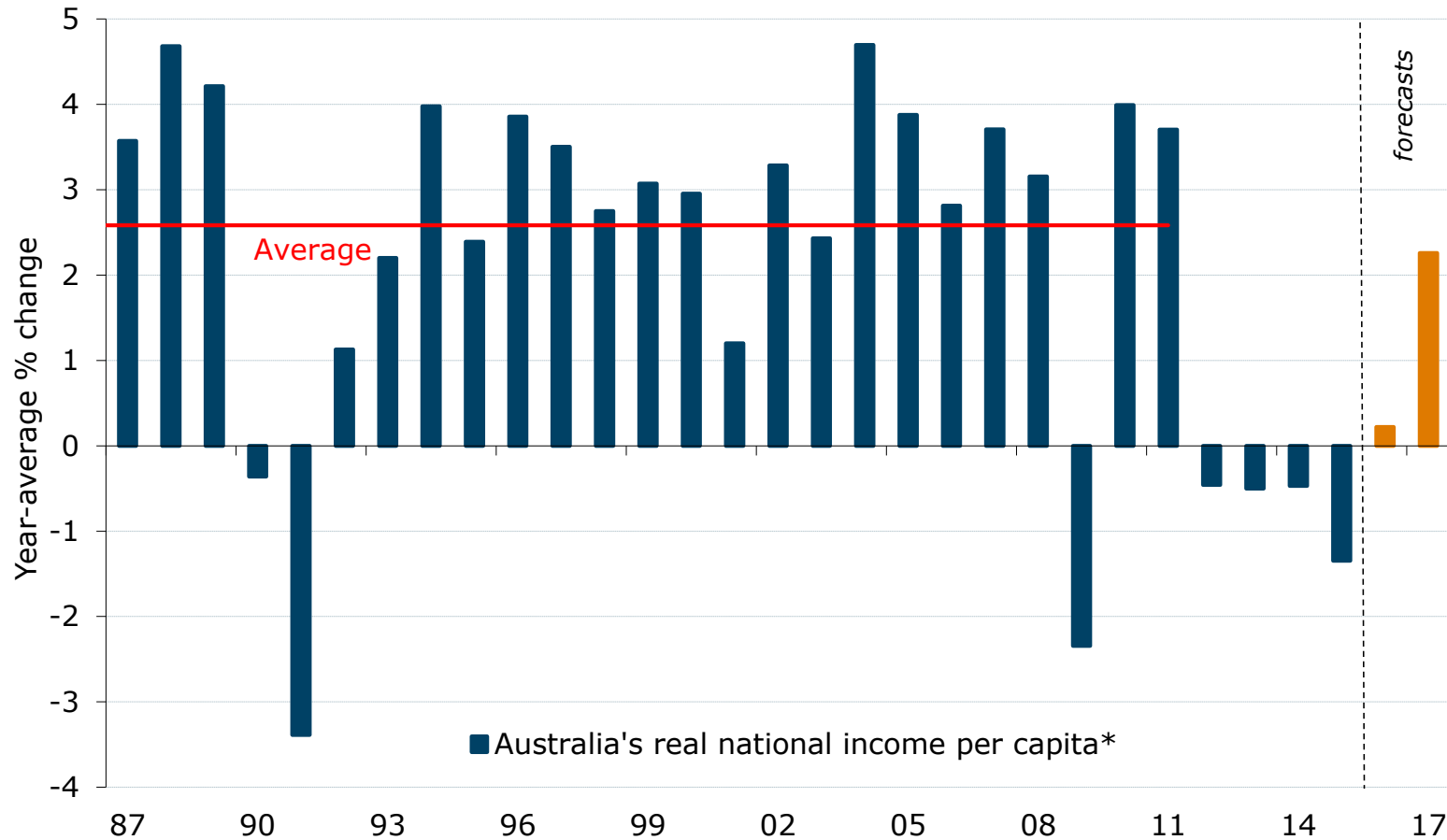
The economy is adjusting to the aftermath of the biggest terms of trade boom ever

The fall in our terms of trade will flow through to our economy for some time yet

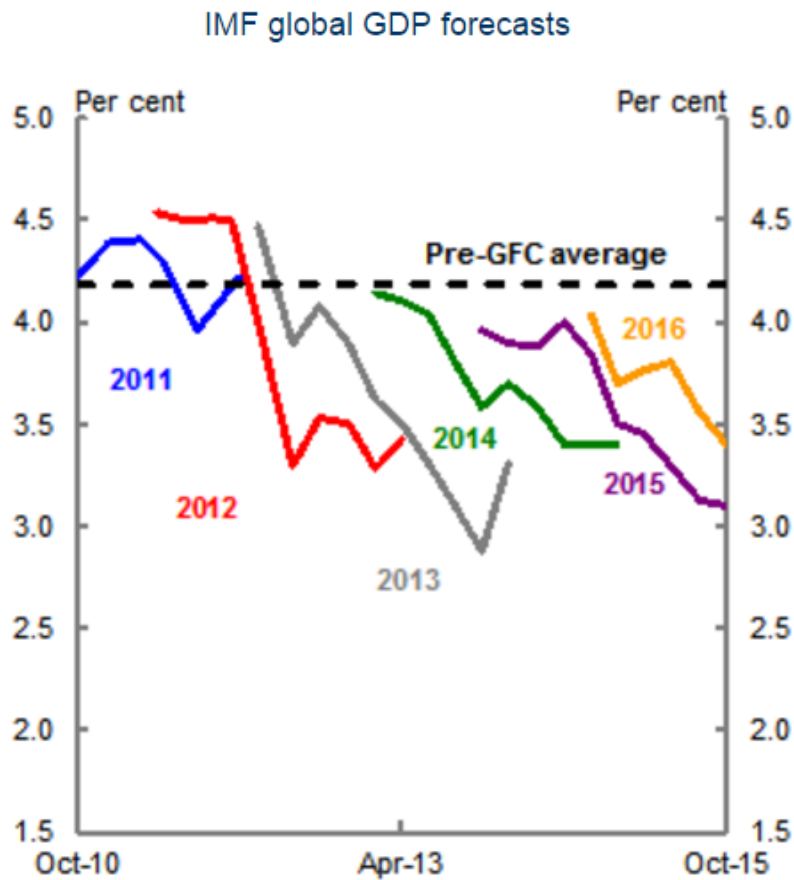
Real national income per capita (year-average)



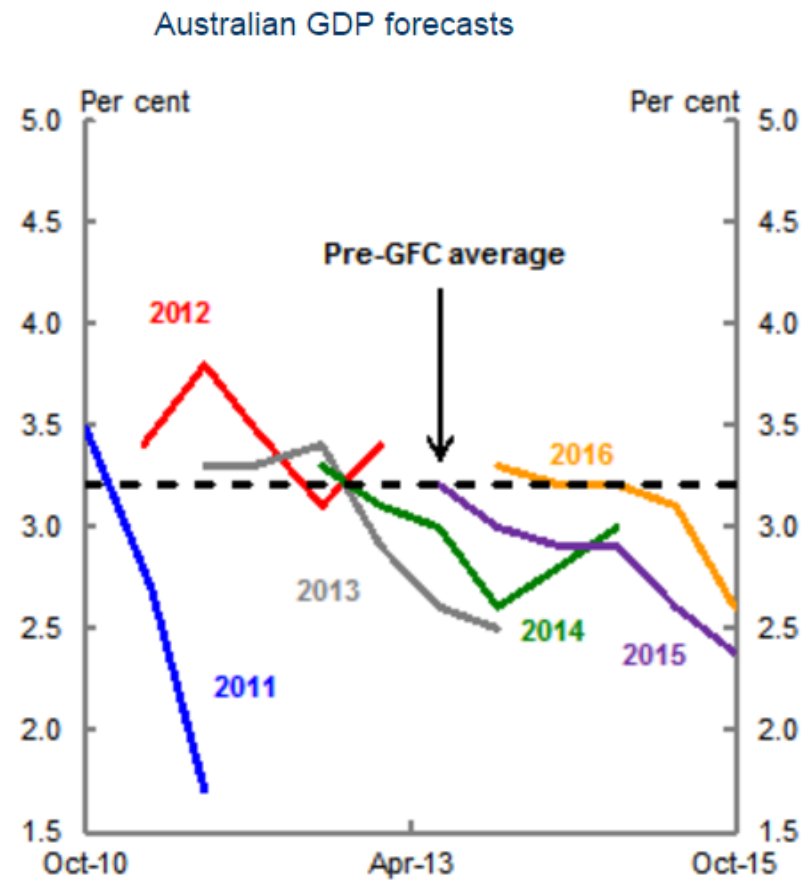
* Real GDP adjusted for the terms of trade, per capita

Evolution of global and Australian GDP growth forecasts



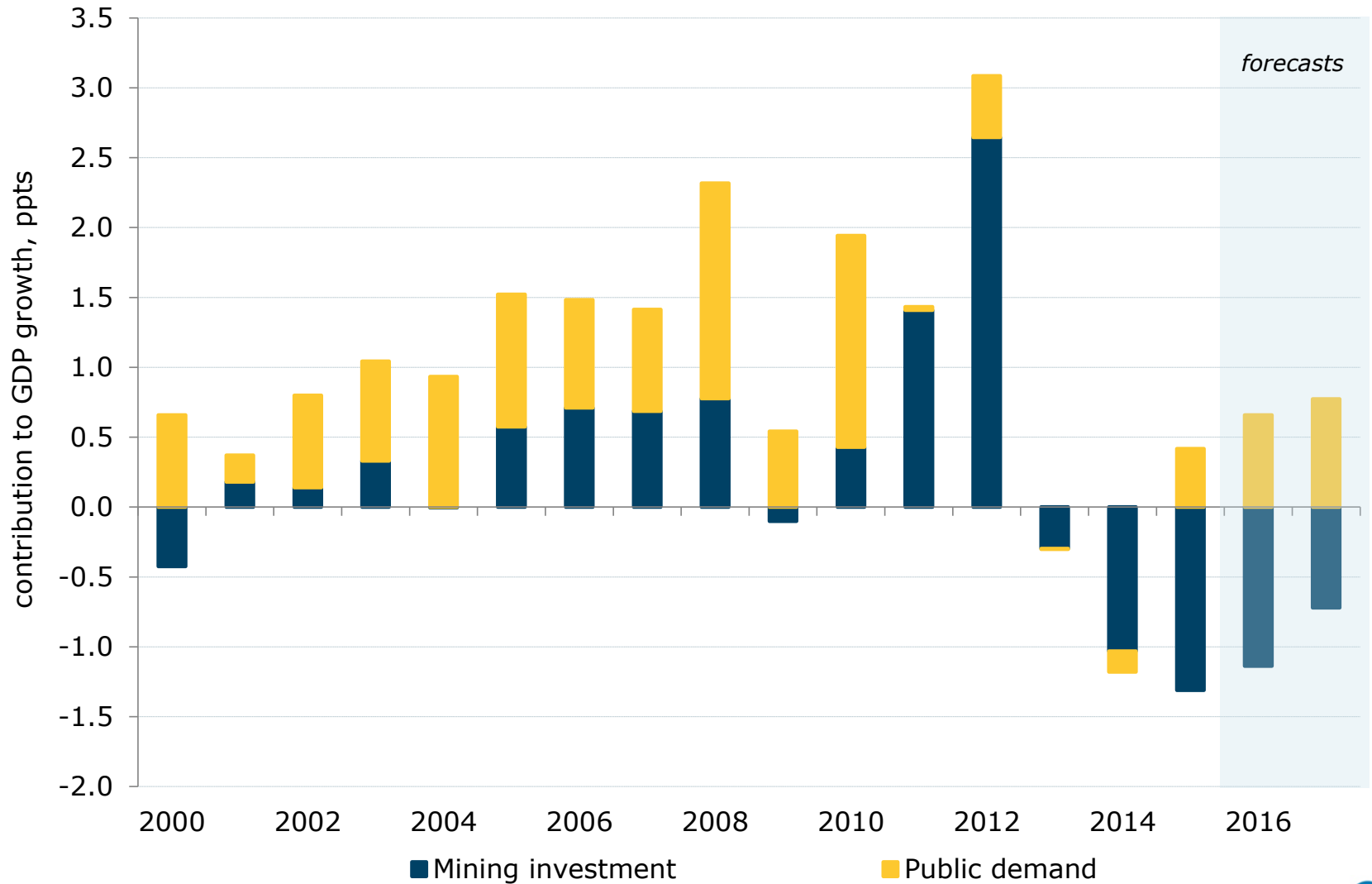

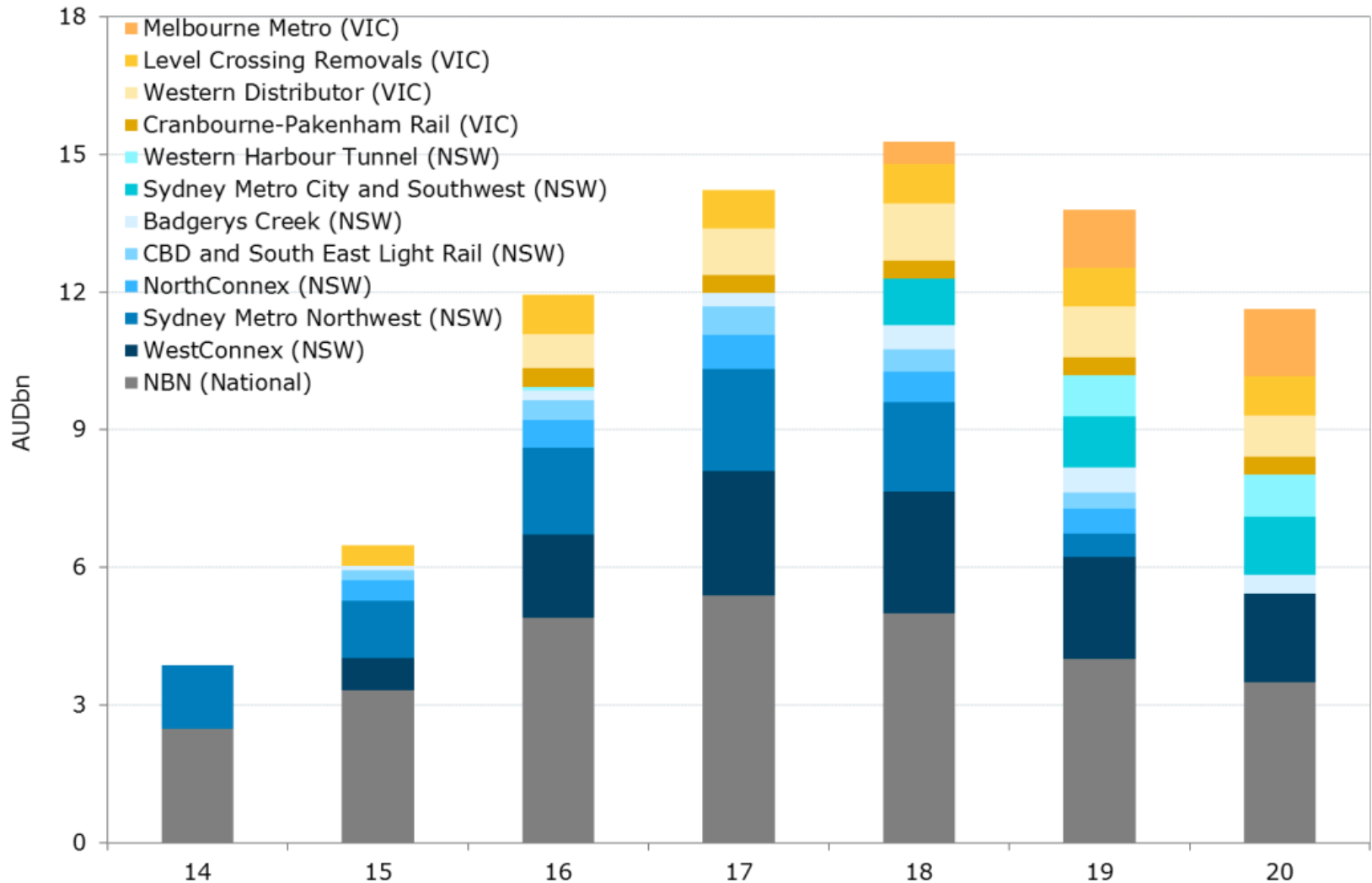

Contributions to GDP growth



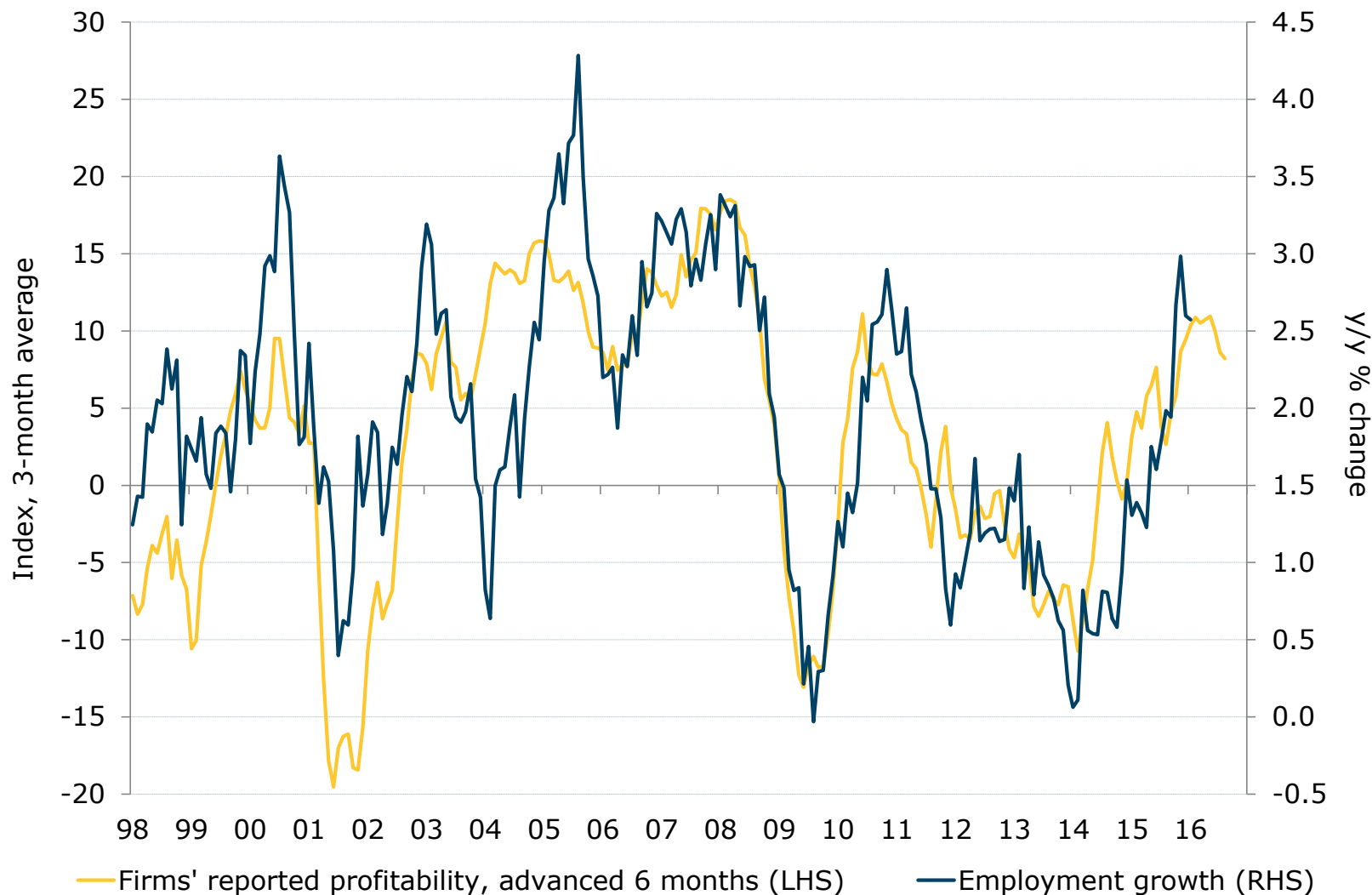
Public investment is set to rise (sharply), particularly in NSW and VIC

Major public backed infrastructure projects



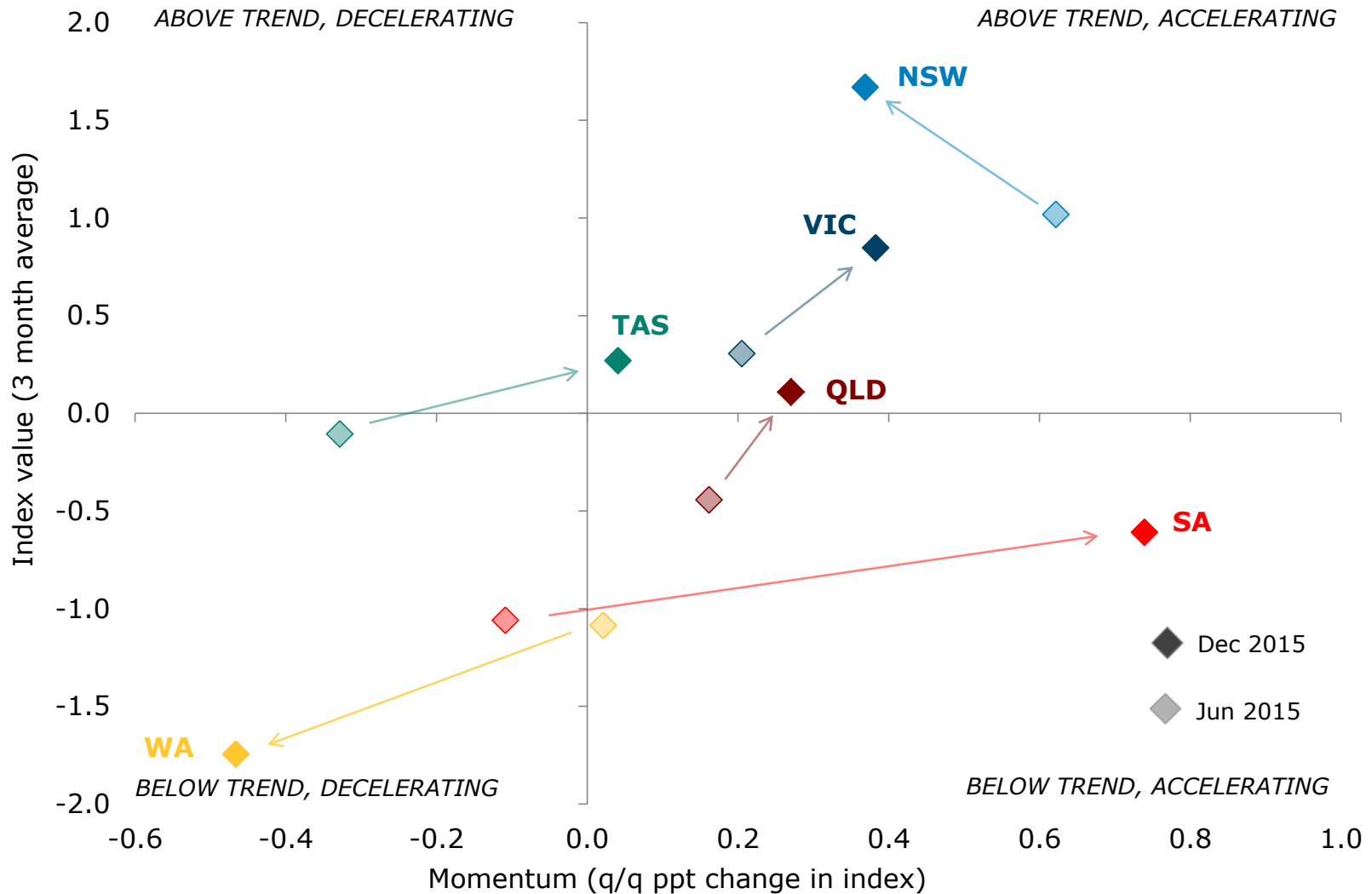
The non-mining economy is improving, led by business and household services

Firms' reported profitability vs employment growth



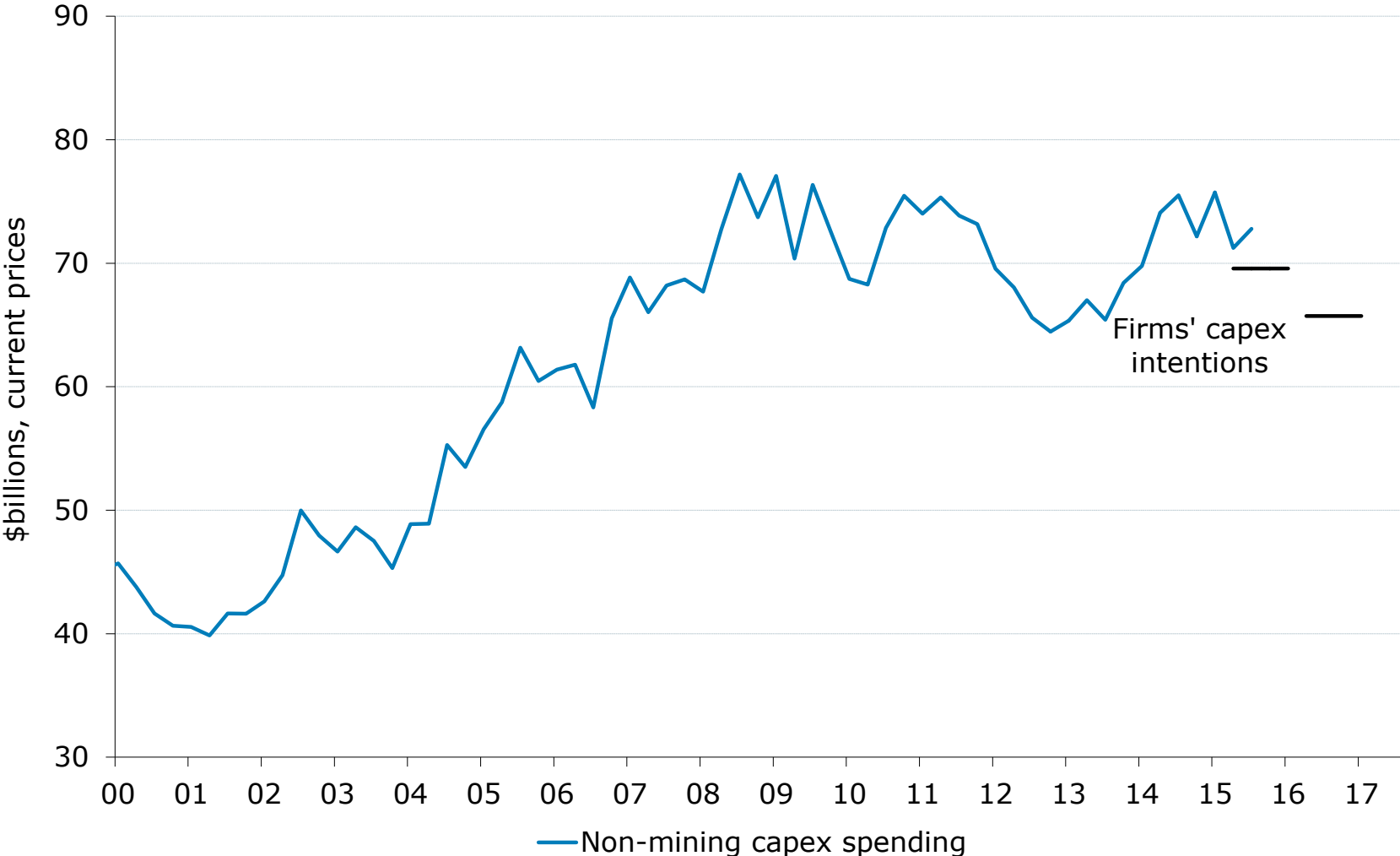
NSW and Victoria are leading the rebalancing of the Australian economy, as the resources downturn weighs on other states and territories

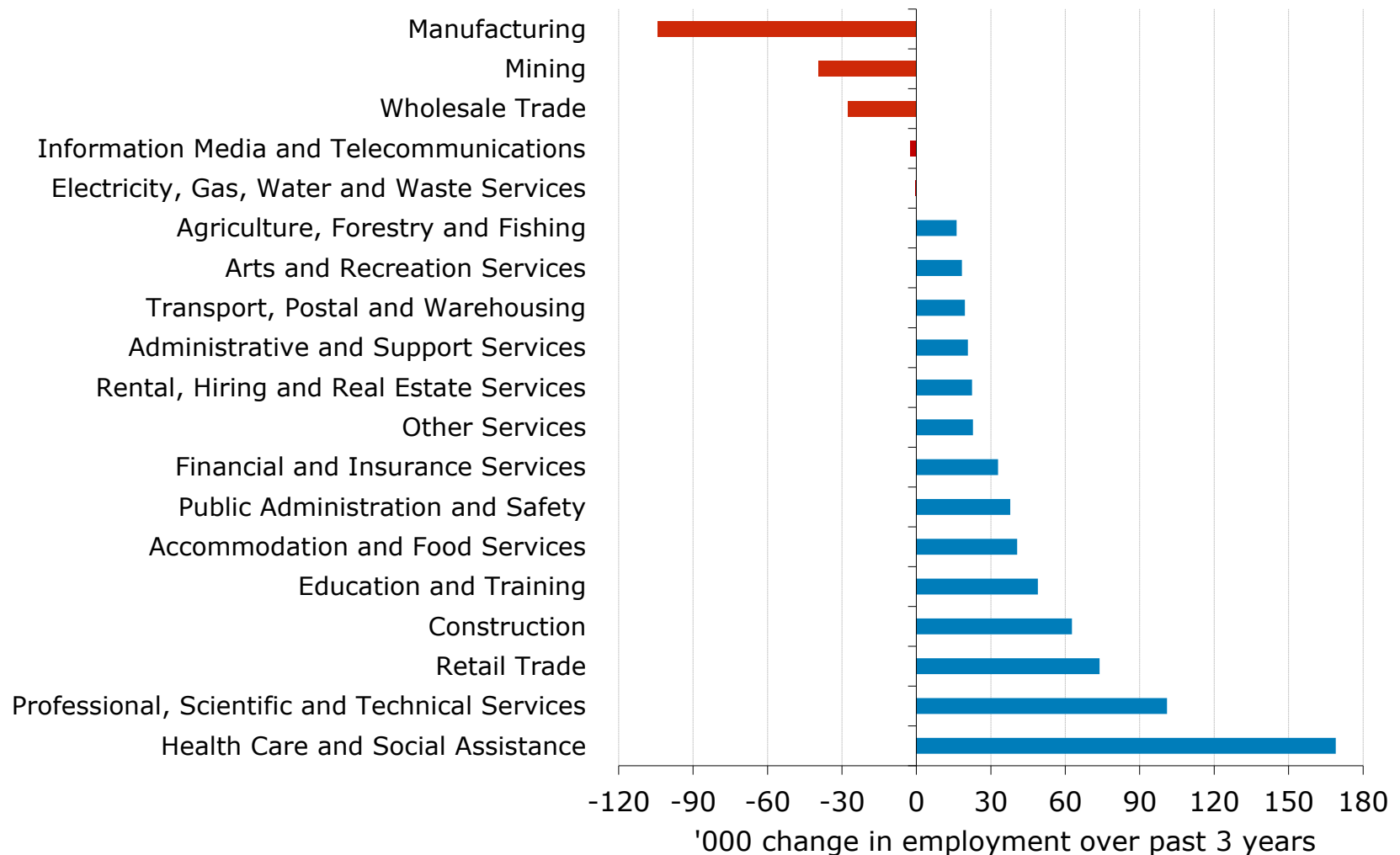

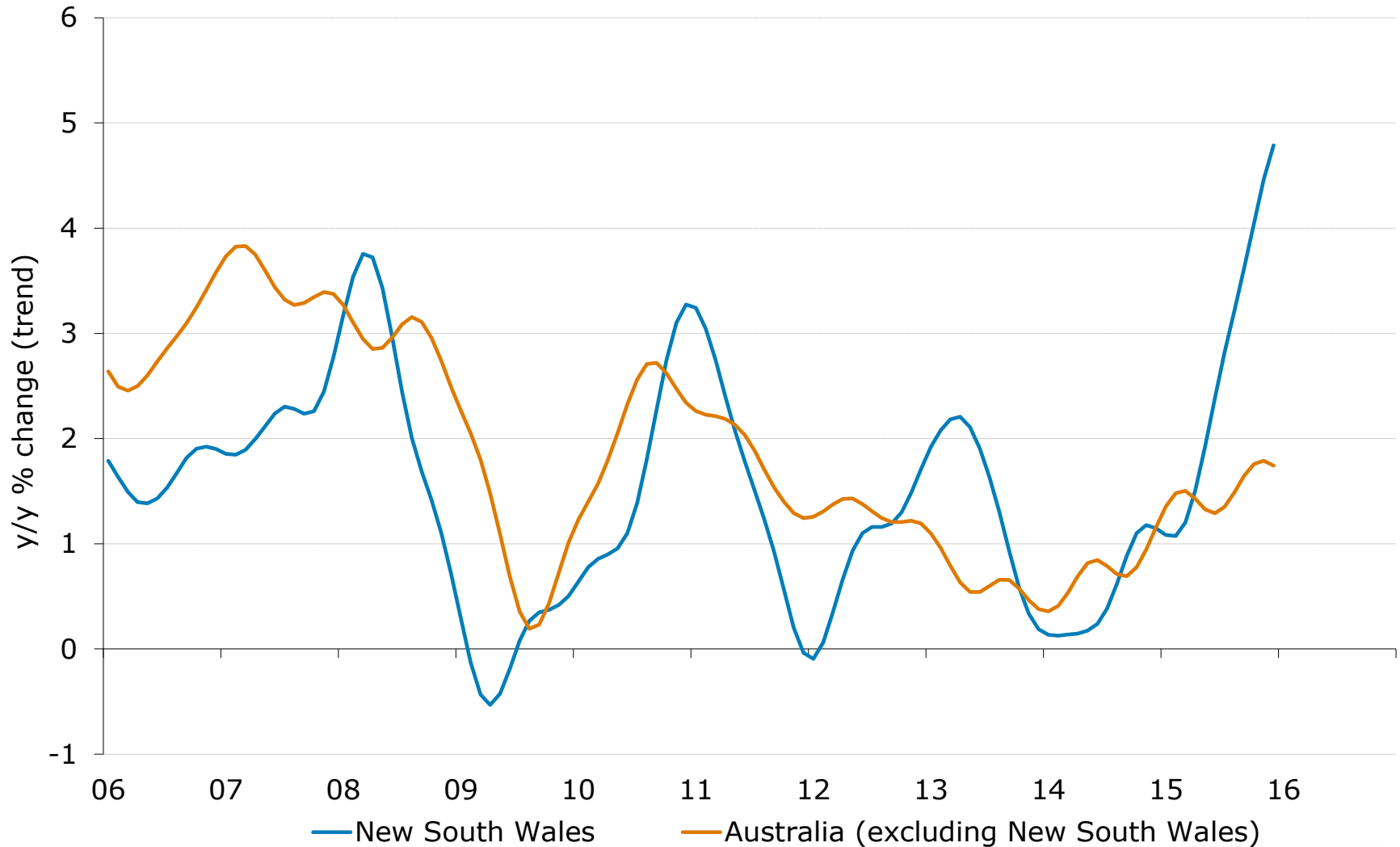

Employment by industry



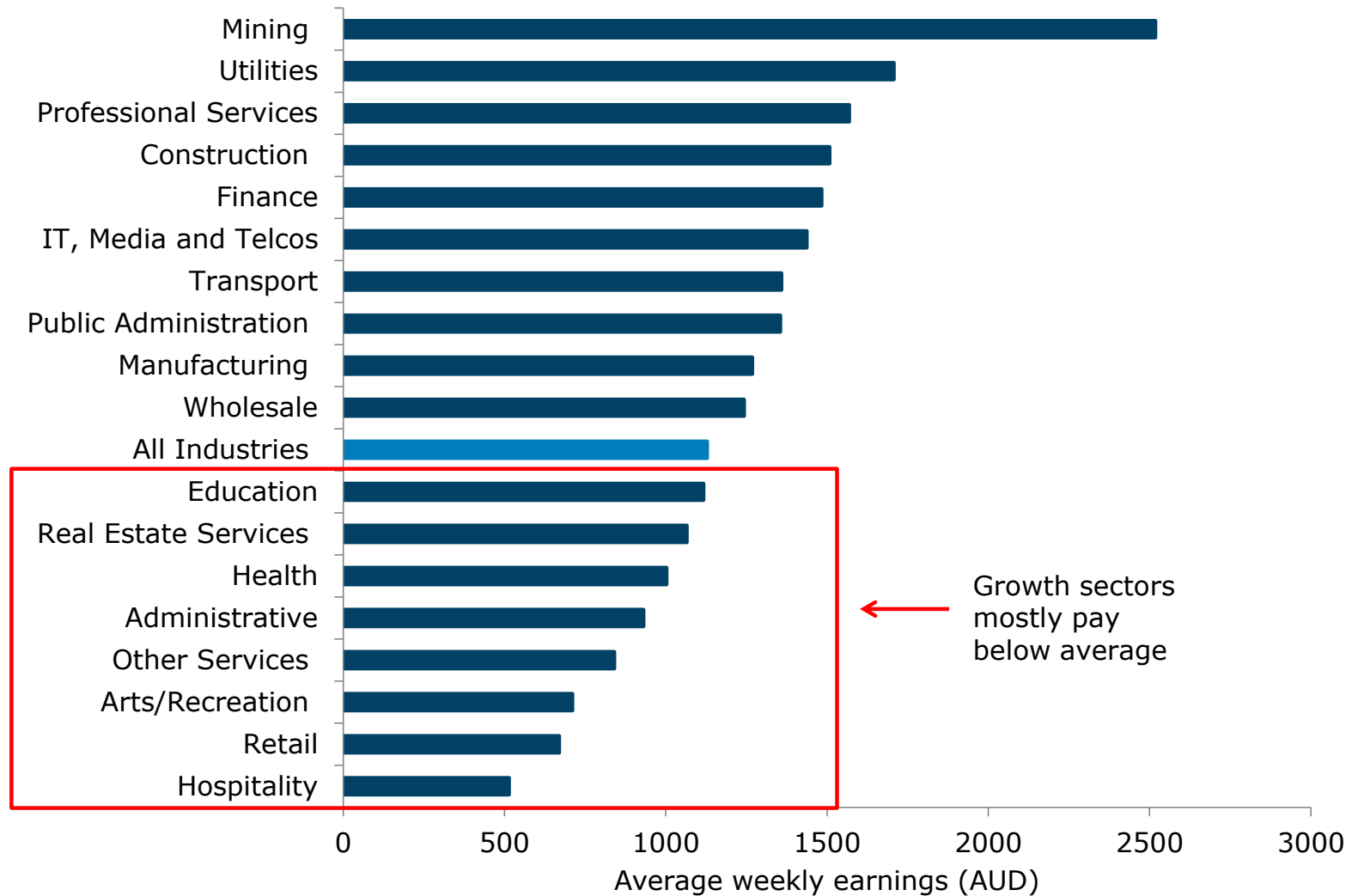
NSW is enjoying the spoils of a services led recovery. The jobless rate in Sydney has fallen to around 4½%, but has also improved noticeably in regional NSW.

But services jobs are relatively low paid

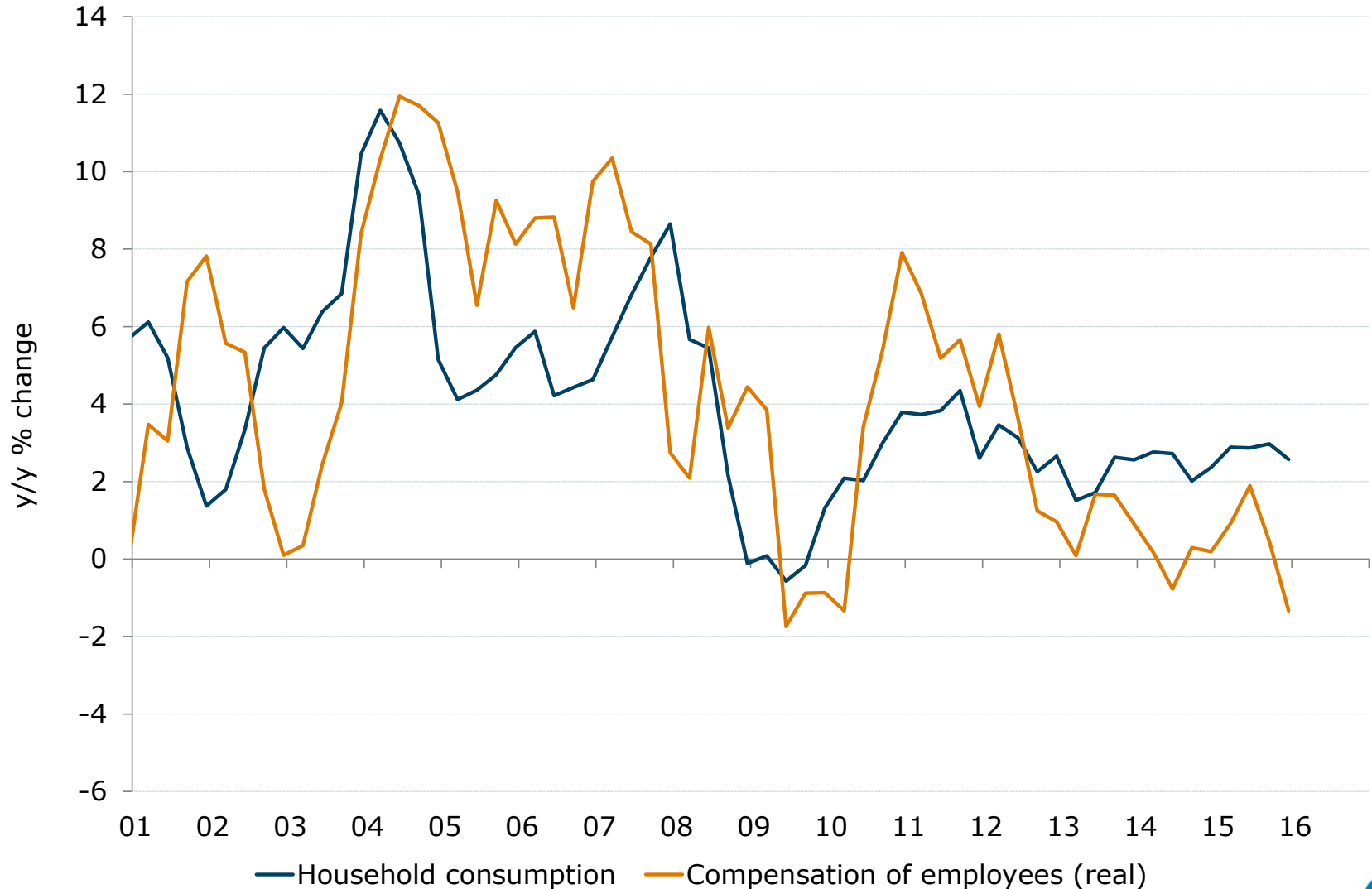
Average weekly earnings by industry



Weak wages growth remains a headwind for consumption.

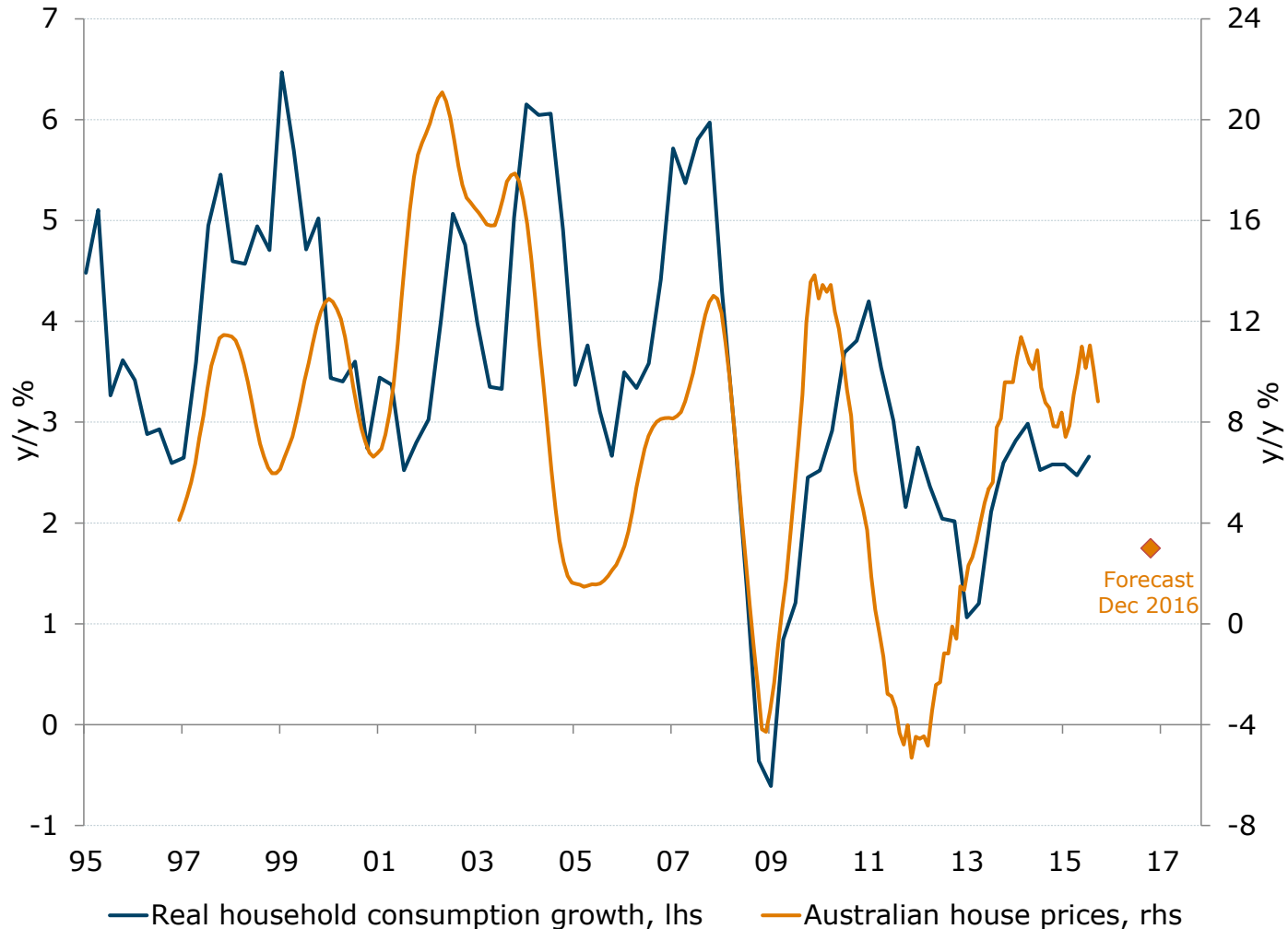

Wages and consumption growth



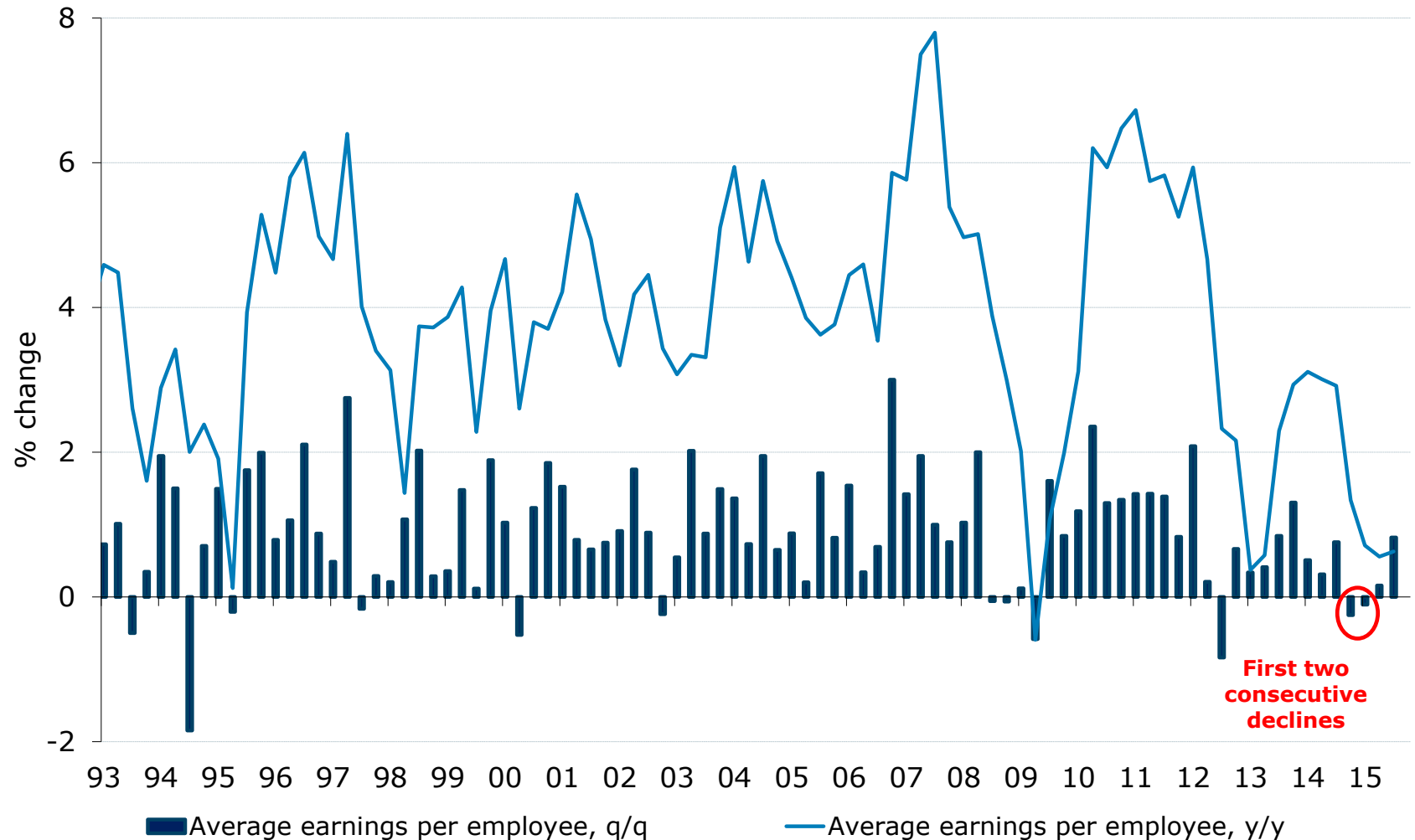
And the boost to household balance sheets from house prices is set to wane

Spending rarely improves as house price growth eases



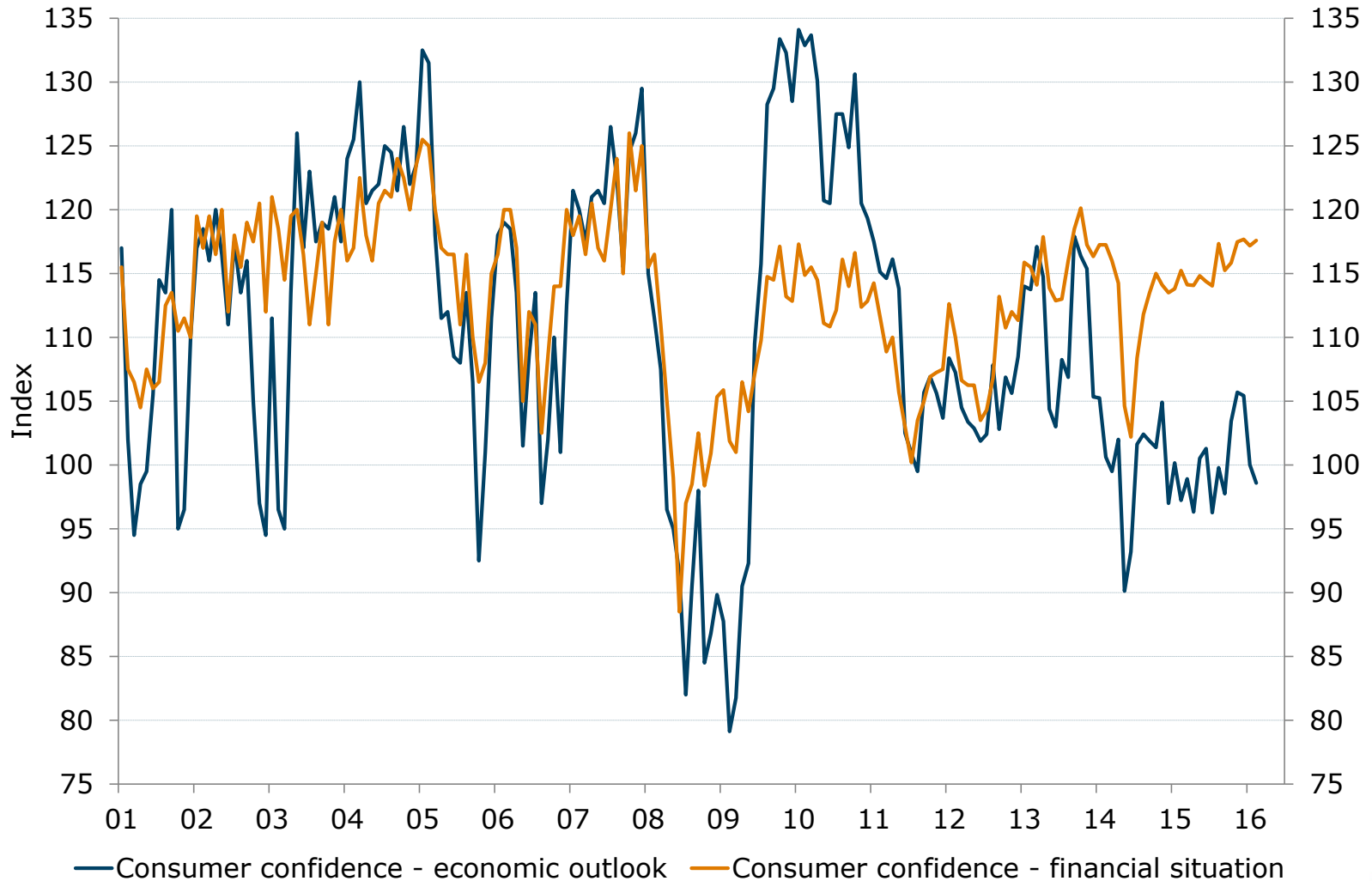

Average wages



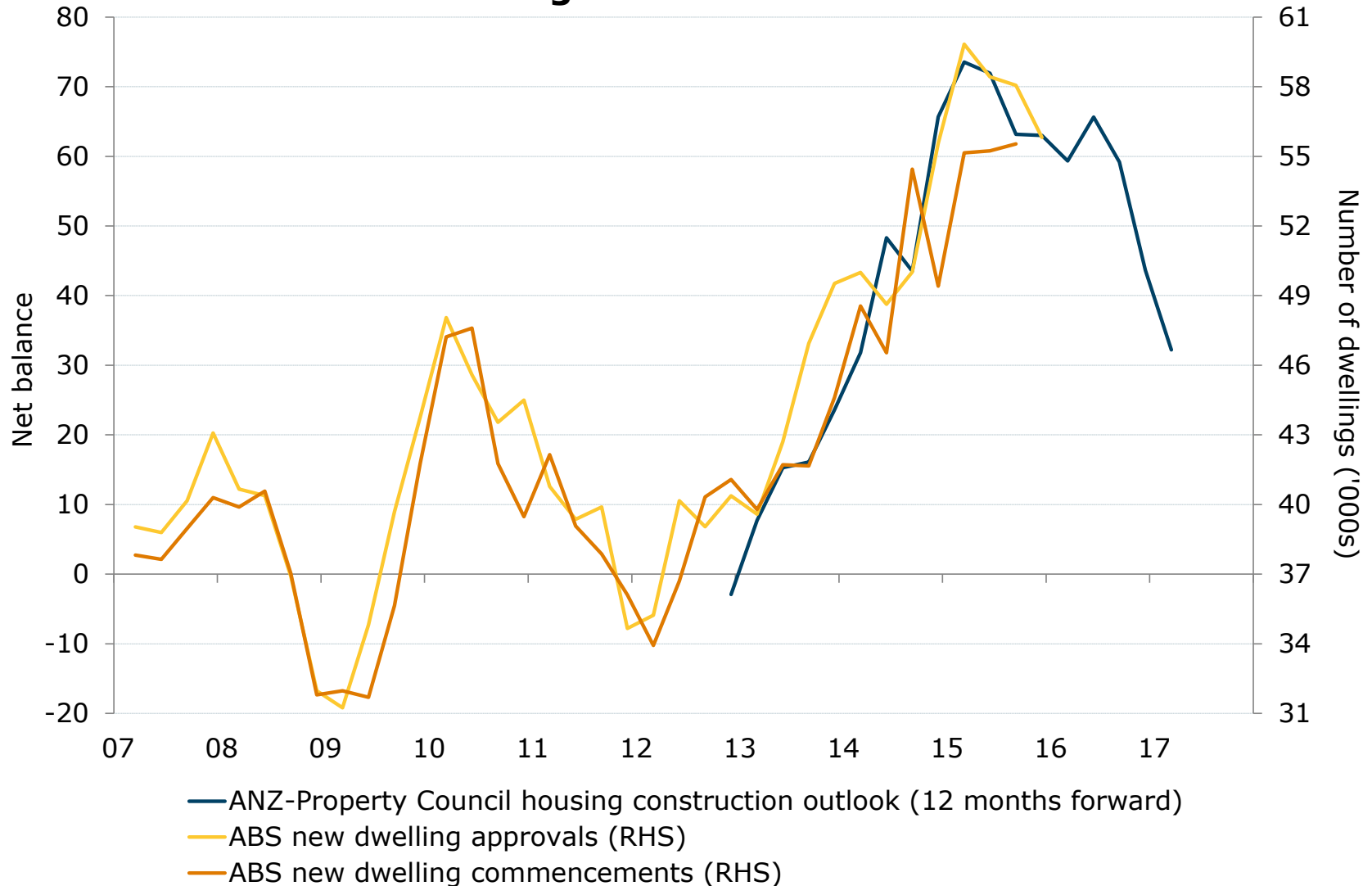

Consumer confidence: Household finances v economic conditions



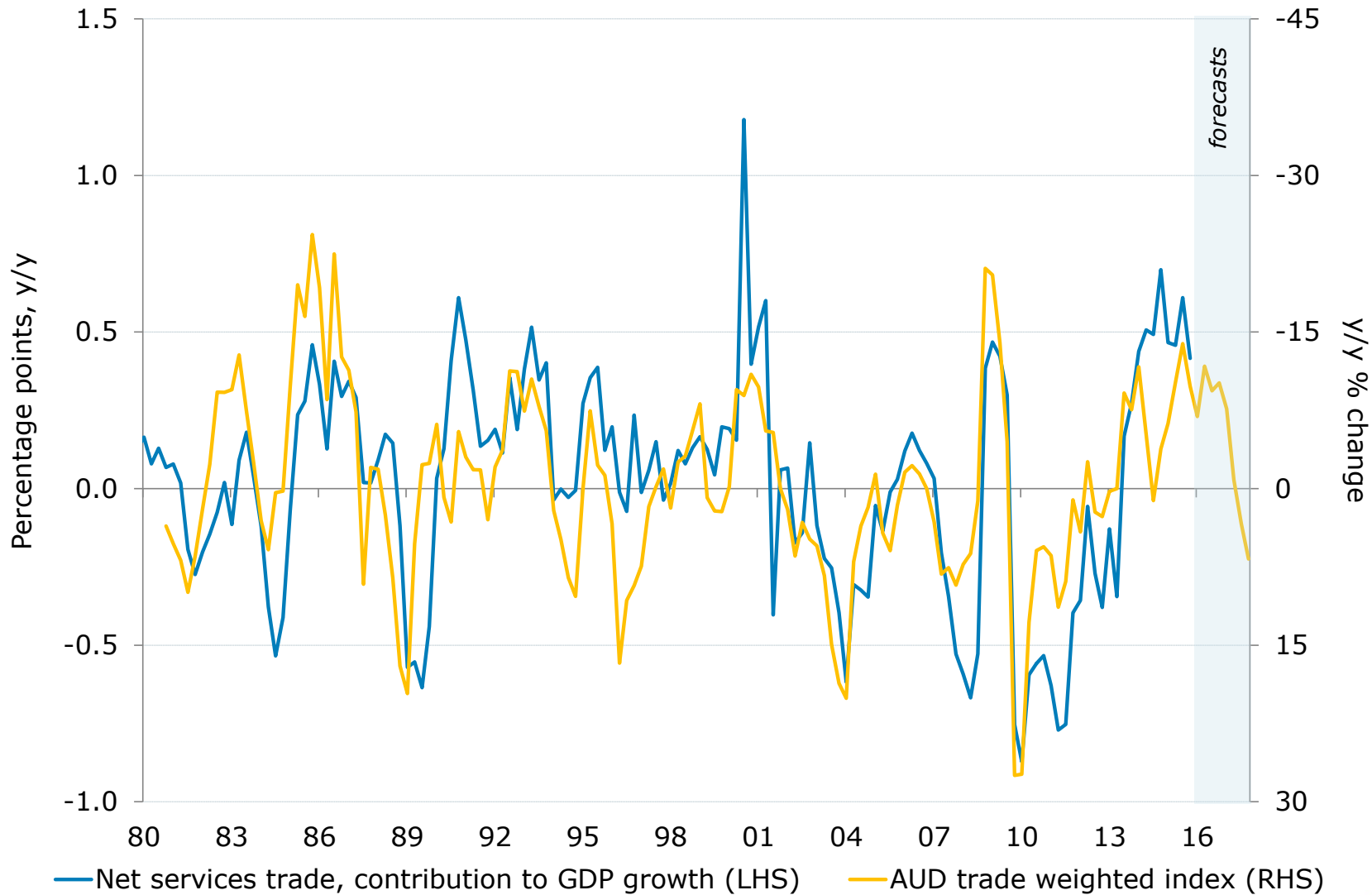
The two key 'tailwinds' for the economy in 2015 will contribute less to growth this year. The housing investment boom is rolling over...

Dwelling investment outlook



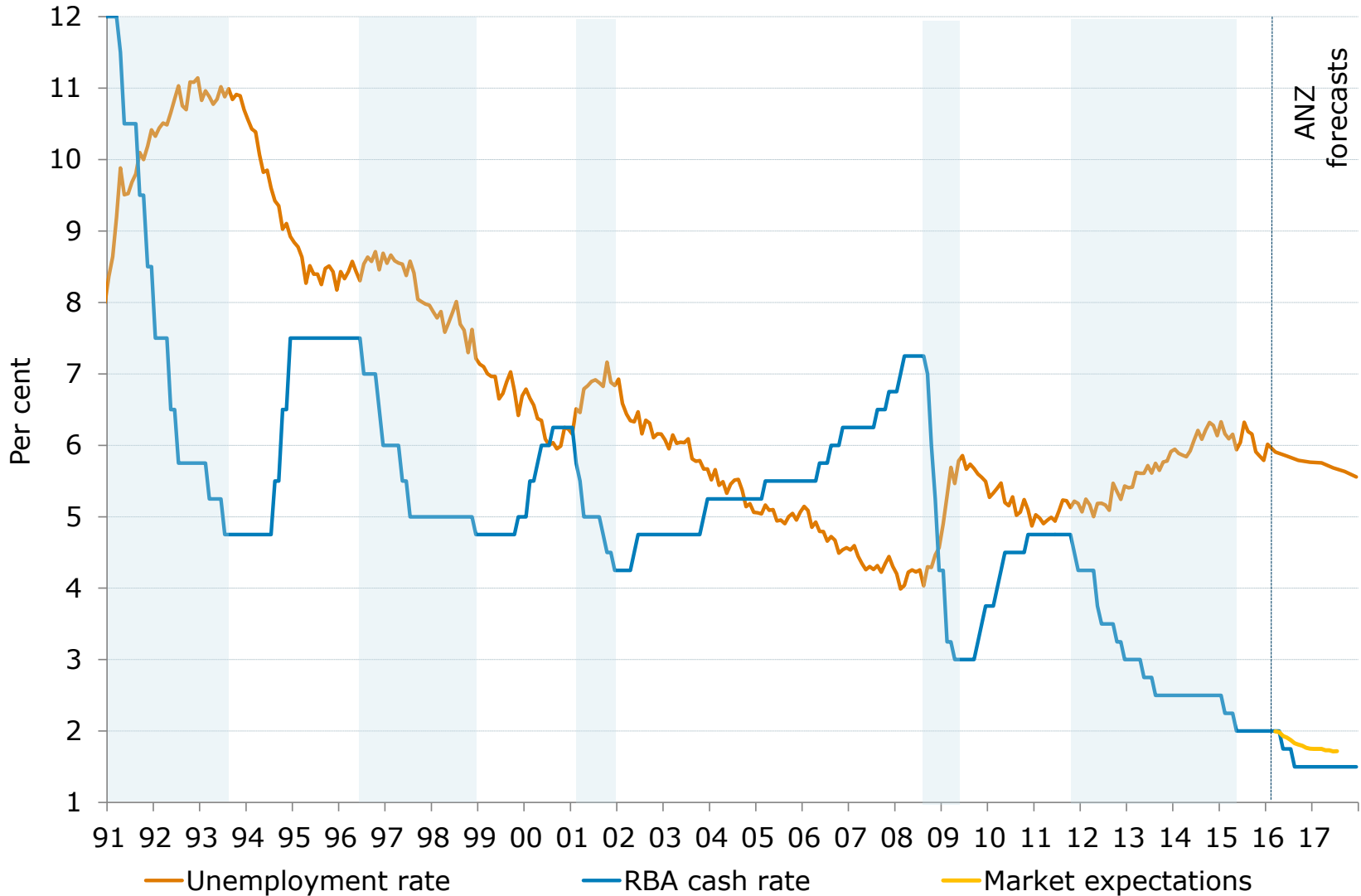

AUD vs net services trade



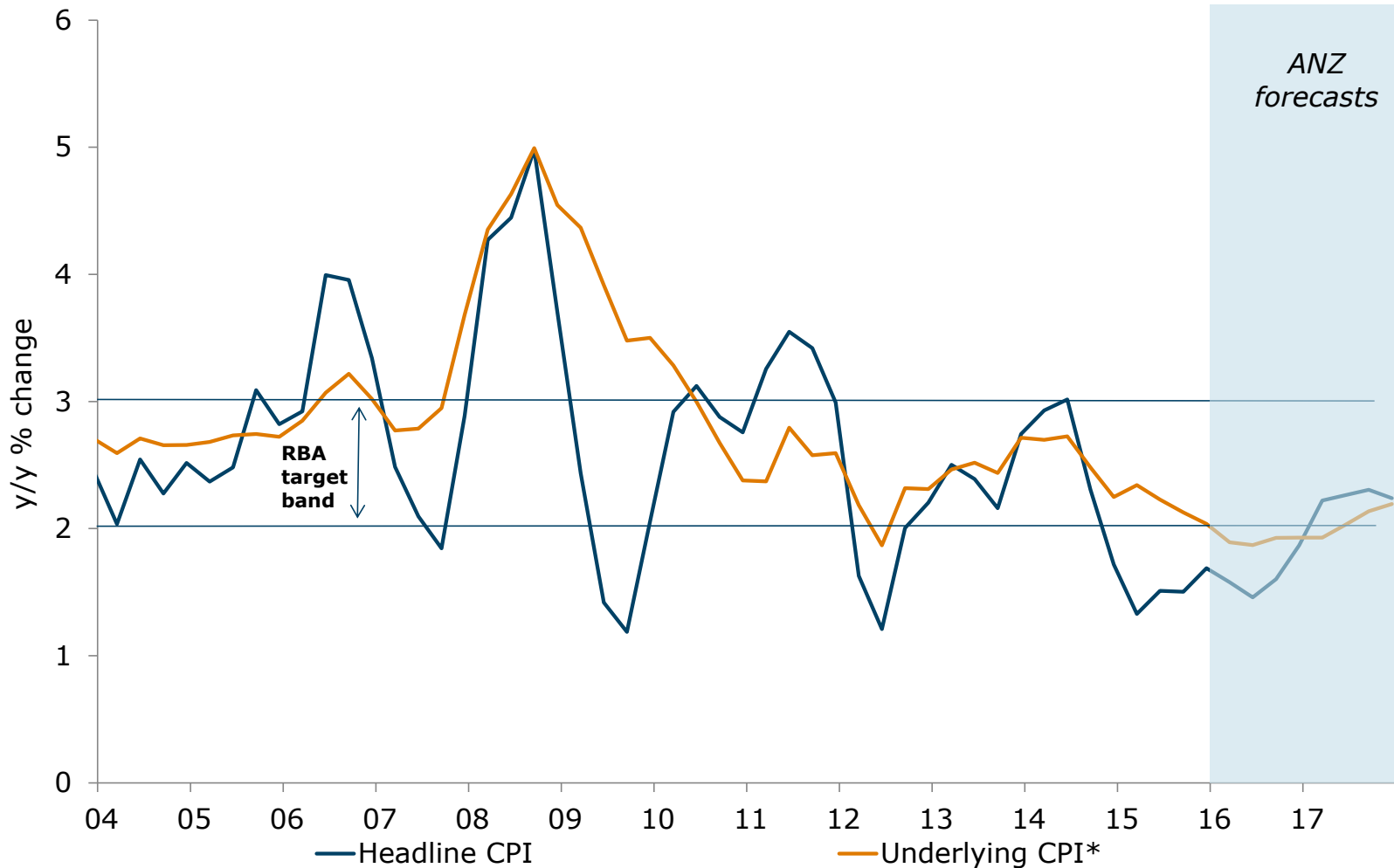

The benign inflation outlook is no impediment to further monetary policy easing should domestic demand need a boost.

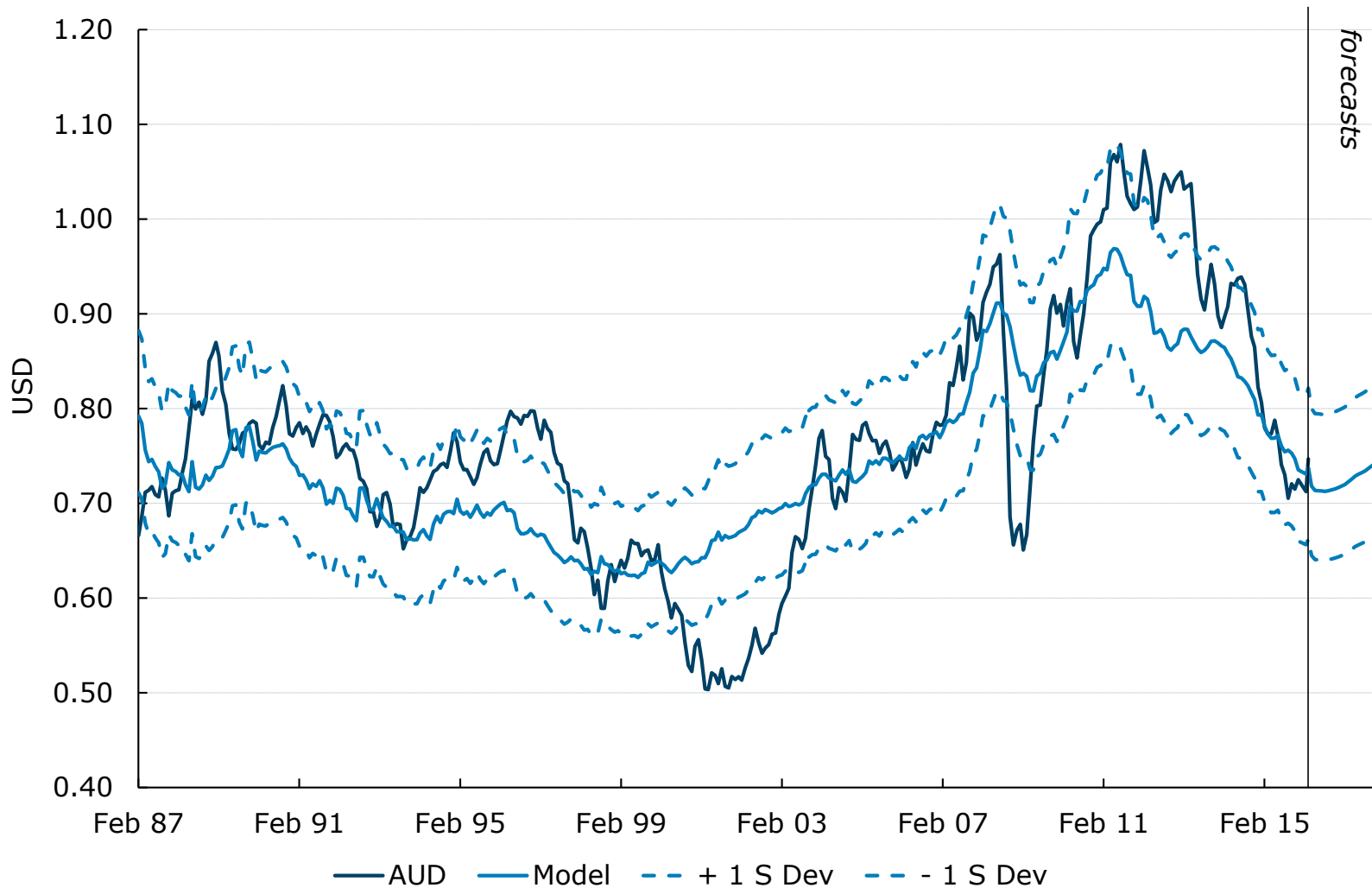
A benign inflation profile
